

**PALM HARBOR GRAND SLAM INNING  
2006 OFFICIAL CONTEST RULES – PHH/KRLD/TSN**

**NO PURCHASE NECESSARY TO ENTER OR WIN.  
A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.  
VOID WHERE PROHIBITED.**

**1. HOW TO ENTER**

- a) The Palm Harbor Grand Slam Inning Contest will begin on April 3, 2006, at approximately 1:05 p.m. Central Time (“CST”) and end on October 1, 2006 (the date of the final 2006 regular season Texas Rangers game) at approximately 8:30 p.m. CST (“the Contest Period.”).
- b) To participate in the contest, complete an official entry form, which includes your first and last name, complete address including zip code, daytime telephone number, date of birth, and your prediction of the inning in which a Rangers player will hit a grand slam, from any participating Texas Palm Harbor Village or Palm Harbor Homes Retail Sales Center at the following locations:

and mail to “Texas Rangers Radio Network, Attn: Palm Harbor Grand Slam Inning, PO Box 191607, Dallas, TX 75219” or send a postcard with your first and last name, complete address including zip code, date of birth, daytime phone and your prediction of the inning in which a Rangers player will hit a grand slam. Neither KRLD nor Palm Harbor Homes is responsible for lost, stolen, mangled, undelivered, postage due, illegible, incomplete or late entries. Each entry must be provided with proper postage and postmark. Entries remain valid for the entire 2006 season. Deadline for entries is 5 p.m. CST on the day prior to each drawing date. See Section 4(b).

- c) Limit one (1) entry per person, per household.

## **2. ELIGIBILITY RESTRICTIONS**

- a. The contest is open to all KRLD listeners 18 years of age or older and who legally reside in Texas. Employees of TSN, KRLD, their corporate parents and licensee, Palm Harbor Homes, their affiliated entities, advertising agencies, participating sponsors/promotional partners, other radio stations in the Dallas/Fort Worth metro area and the members of their immediate families are ineligible to participate or win.
- b. Only one (1) winner per household is permitted in any contest.
- c. Listeners are eligible to win a TSN or KRLD prize valued at \$600 or more only once every six (6) months.
- d. Incomplete entries will be declared invalid and shall be rejected. Contestants are required to provide truthful information and KRLD/TSN will reject and delete any entry it discovers to be false or fraudulent. KRLD will also disqualify and delete any entry received from persons under the age of 18.

## **3. CONTEST & PRIZE**

- a. If any Rangers player hits a grand slam home run in the inning predicted by the randomly-drawn contestant for that Rangers game, that contestant will be a Winner and receive a 2,356 square foot Palm Harbor Home (“Grand Prize”), 4-Bedroom, 2-Bath, 2-Living Area Model 76I3 Windsor series, valued at \$75,283. Grand Prize includes dishwasher, range, side-by-side refrigerator, fireplace and built-in entertainment center. Grand Prize does not include lot or real property, landscaping, land improvements such as grading, sidewalks, driveway, septic system or utility provisions. Winner is subject to the terms and conditions of the Grand Prize provider. Additional expenses may be incurred by the Winner for installation requirements above and beyond a normal installation due to site restrictions, drainage or grade in elevation. All other costs associated with the Grand Prize, including, but not limited to, payment of all federal, state and local taxes, purchase of real property lot, and recording fees, are the sole responsibility of Contest Winners. If more than one grand slam is hit by Rangers players in the predicted inning, only one (1) Grand Prize will be awarded. Any predicted inning in which any Rangers player hits a grand slam must occur during a regular season game counted as an Official League game. See Section 5(d).
- b. Any prize not claimed within forty-five (45) days of winning will be forfeited by the winner.
- c. Contest prizes are not transferable. Prize may not be substituted for or redeemed for cash, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply. If winner is unable to accept or cannot accept the grand prize Palm Harbor Home, the Prize will be forfeited.

## **4. WINNER SELECTION AND NOTIFICATION**

- a. Decisions of TSN, KRLD and Palm Harbor Homes management with respect to the contest are final.
- b. One (1) contestant will be chosen by random drawing from all eligible entries received for each 2006 regular season Texas Rangers game played during the Contest Period. If any Rangers player hits a grand slam home run in an inning predicted by a chosen contestant, that contestant will be a Grand Prize Winner. Drawings of all entries received by 5 pm each Monday prior to each drawing which will be held on each Tuesday prior to the week that a Texas Rangers game is played. One contestant will be selected for each game to be played the following week. For each game, the chosen contestant and predicted inning will be announced on the Rangers Radio Network during the inning chosen by that contestant.
- c. Odds of winning depend upon the number of eligible entries received.
- d. If no correct predictions are made, no Palm Harbor Home will be awarded.
- e. Winners need not listen/or be present to win and will be notified by phone and/or mail immediately following the inning in which the winner is determined. Selected contestants will not be notified prior to each game.

## 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners may be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, KRLD/TSN in its sole discretion may require contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold TSN, KRLD, their corporate parents and licensee, Palm Harbor Homes, affiliate companies and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- d. KRLD/TSN reserves the right to make changes in the rules of the contest, including the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of KRLD/TSN the game in which a grand slam occurs is cancelled for any reason prior to becoming an official game, all statistics are removed from the official score book and the Grand Prize will not be awarded. If a game is delayed or postponed before the grand slam inning is played, the contest will occur when the rescheduled or postponed game is played.
- e. KRLD/TSN reserve the right, but not the obligation, to cancel or modify the contest and shall not be required to award a substitute prize.

- f. Failure to comply with the contest rules may result in a contestant's disqualification solely at the discretion of KRLD/TSN.
- g. KRLD/TSN are not responsible for typographical or other errors in the printing, the offering or the administration of the contest, or in the announcement of a prize.
